The volunteers, who serve without compensation, are appointed based on their interest and expertise in areas such as public safety, economic development, land development, streets, water, and community enhancement. All meetings are open to the public.

Advisory Committee and Commission members serve at-will and at-large.

All Committees and the Planning Commission fall within the guidelines of the Brown Act (California Government Code § 54950 et seq.) and as such all meetings are open to the public.

Applications may be submitted at any time and are kept on file for one year to be reviewed for regular appointments or if an unexpected vacancy occurs.

## City Council Advisory Committee

The City Council Advisory Committee is an advisory resource to the City Council. At the discretion of the City Council, the Advisory Committee shall review the Capital Improvement Project Plan (CIP) including the recommendation of streets on the annual road paving list, as well as water and sewer capital expenditures, traffic flow and signage, public safety services including contract performance/costs and possible expansion of public safety program services and franchised service providers to ensure top quality service and public trust. The Committee also reviews economic development and housing programs, as well as the Community Development Block Grant (CDBG) funds. The Advisory Committee can also perform other duties assigned by the City Council.

Applicants must be United States Citizens as evidenced by current registered voter status residing within the City of Hesperia

The five-member Committee meets quarterly (January, April, July and October) on the 2<sup>nd</sup> Wednesday @ 6:00 p.m.

## Public Safety Advisory Committee

The Public Safety Advisory Committee is an advisory resource to the City Council. At the discretion of the City Council, the Advisory Committee shall review, research and provide recommendations on any issue, program, goal or item as assigned by the City Council. Functional areas include, but are not limited to: review of public safety services including contract performance / costs and the possible expansion of public safety programs and services; fiscal soundness for public trust; review of service providers to ensure top quality service; opportunities for joint programs with other local public agencies, as well as opportunities for public / private partnerships that benefit Hesperia and other duties assigned by the City Council.

Applicants must be United States Citizens as evidenced by current registered voter status residing within the City of Hesperia.

The five-member Committee meets annually in January, or as needed, on the 2<sup>nd</sup> Tuesday @ 6:00 p.m.

## Planning Commission

The Planning Commission is responsible for reviewing and making recommendations to the Council regarding the General Plan, the Development Code, and approving land subdivisions. It promotes the coordination of local plans and programs with other public agencies. Commissioners receive a stipend of \$100 per meeting attended.

Applicants must be United States Citizens as evidenced by current registered voter status residing within the City of Hesperia or within its sphere of influence.

The five-member Commission meets at 6:30 p.m. on the 2<sup>nd</sup> Thursday of each month and the 4<sup>th</sup> Thursday, as needed. Special meetings may be called from time to time.

Planning Commission Members are required to file Form 700 Conflict of Interest Statements with the Fair Political Practices Commission.
