Pursuant to the United States Department of Housing and Urban Development (HUD) regulations, the City of Hesperia has prepared the draft Consolidated Annual Performance Evaluation Report (CAPER) for the 2014-2015 Community Development Block Grant (CDBG) Program Year.

The CAPER provides an assessment of the City's performance in meeting Fiscal Year 2014-2015 housing and community development goals as outlined in the previously adopted Fiscal Year 2014-2015 One-Year Action Plan. Additionally, the CAPER discusses changes the City anticipates making in the upcoming year as a result of the assessment of FY 2014-2015 annual performance.

In compliance with the City's approved Citizen Participation Plan and the Consolidated Plan implementing regulation 24 CFR 91.105, this notice is hereby given that the City of Hesperia has prepared the CAPER for FY 2014-2015. A copy of the CAPER is required to be made available to the public for review and comment for a fifteen (15) day period. The CAPER draft was available for public review from August 17, 2015 to September 1, 2015, at the following locations:

- Hesperia Public Library, 9650 Seventh Avenue, Hesperia
- Hesperia City Clerk's Office, 9700 Seventh Avenue, Hesperia
- Hesperia Economic Development Department, 9700 Seventh Avenue, Hesperia

A Public Hearing to solicit public comment from interested citizens will be held on September 15, 2015, at 6:30 p.m. at the Hesperia City Council Chambers, located at 9700 Seventh Avenue. The purpose of the Public Hearing for the CAPER is to allow the public the opportunity to comment on the manner in which the City utilized federal and non-federal funds for the one-year period that ended on June 30, 2015.

It is the objective of the City to comply with Section 504 of the Rehabilitation Act of 1973, as amended, the Americans with Disabilities Act (ADA) of 1990 and the ADA Amendment Act of 2008, the Fair Housing Act, and the Architectural Barriers Act in all respects. If you require public documents in an accessible format, the City will make reasonable efforts to accommodate your request. If you require a disability-related accommodation to attend or participate in a hearing or meeting, including auxiliary aids or services, please contact the City Clerk's Office at least 48 hours prior to the meeting at (760) 947-1007 or (760) 947-1056.

The City of Hesperia encourages citizen participation in the CDBG process. The public is invited to submit written comments, which will be forwarded to HUD along with the Final 2014-2015 CAPER.
